Restrictions at Blue Flag Bathing Zone

(GOLDEN BEACH AT PURI)

It is hereby informed to the general public that the stretch of beach at Puri town (between Gandhi Park and Hotel Mayfair) has been developed as a Pilot Blue Flag Beach with a view to promote sustainable tourism in the Puri district by maintaining high water quality, safety and environment management standards while imparting environmental education.

It is further informed that a stretch of 200m length X 30m width of the above mentioned area has been identified as "Safe Swim Heaven", after a detailed survey of the beach by an expert agency namely; NCSCM, Chennai, India. This area being demarcated by dual colour flags (Red and orange) and duly fenced with ropes & buoys is considered to be the safest place of the beach, where the conditions are most favourable to swimmers and bathers. After successful implementation of the project through compliance of 33 criteria stipulated by an international body namely; Foundation of Environmental Education (FEE, Denmark), a proposal will be submitted to consider according accreditation in favour of this beach as a safe and clean beach.

Keeping this in view and to facilitate tourists inflow to the designated blue flag beach, public is hereby advised to use this area duly cordon off with ropes and buoys for bathing and swimming purposes only. No other activities such as water sports and/ or fishing, which have potential to degrade water quality and which may hamper safety of swimmers, shall not be undertaken in this designated beach with effect from the date of this Notice. Any person violating the above instructions will be penalised under law.

No Transport Zone in Golden Beach at Puri

It is hereby informed to the general public that the stretch of beach at Puri town (between Gandhi Park and Hotel Mayfair) has been developed as a Pilot Blue Flag Beach with a view to promote sustainable tourism in the Puri district by maintaining high water quality, safety and environment management standards while imparting environmental education.

After successful implementation of the project through compliance of 33 criteria stipulated by an international body namely; Foundation of Environmental Education (FEE), a proposal will be submitted to consider according accreditation in favour of this beach as a safe and clean beach.

Keeping this in view and to facilitate tourists inflow to the designated blue flag beach, public is hereby advised not to use or drive any public or personal or private vehicles within the area of the Blue Flag beach demarcated by an area of 900 metre x 110 metres duly fenced from 3 sides. No other activities, concerning the driving of any motor vehicles can be undertaken in this designated area. Any person violating the above instructions will be penalized under law.

No Plastic Zone in Golden Beach at Puri

It is hereby informed to the general public that the stretch of beach at Puri town (between Gandhi Park and Hotel Mayfair) has been developed as a Pilot Blue Flag Beach with a view to promote sustainable tourism in the Puri district by maintaining high water quality, safety and environment management standards while imparting environmental education.

After successful implementation of the project through compliance of 33 criteria stipulated by an international body namely; Foundation of Environmental Education (FEE), a proposal will be submitted to consider according accreditation in favour of this beach as a safe and clean beach.

Keeping this in view and to facilitate tourists inflow to the designated blue flag beach, public is hereby advised not to use restricted plastic items as notified by State Government vide Order No. 21103/F&E/ENV-1-57/2018 dated 29 September 2018 within the area of the Blue Flag beach demarcated by an area of 900 metre x 110 metres duly fenced from 3 sides. Violation of the provisions of above Notification will attract penalty as per Environment (Protection) Act, 1986.
